501(c)(3) Status: Good News and Sorta Bad News

In early April we received confirmation from the IRS that the 1023 application submitted on behalf of “Masonic Charities of Hawaii” was approved. Effective March 31, 2010, the Grand Lodge finally has a legitimate 501(c)(3) organization, which is tax-exempt as a “public charity”. Therefore, donations made to this entity are tax-exempt from state and federal taxes (including excise taxes), and are tax deductible by the persons making such donations.

Many simply have assumed that donations made to the Grand Lodge were (are) tax-deductible. Although the Grand Lodge is a nonprofit, it is tax-exempt for certain purposes as a fraternal organization under 501(c)(10). Dues (per capita tax) might not be taxed as income, but they are not considered tax-deductible donations. Neither are donations to the “building fund” automatically deductible by the donor. There is authority supporting the view that contributions earmarked for a charitable, scientific, artistic, etc. purposes may be tax-deductible. But as we attorneys are accustomed to saying, “I express no opinion on the accuracy or validity of that view.”

This is why MCH’s classification is so important. It means that donors can make contributions that are automatically tax-deductible by them to the same extent as gifts to your church, the American Red Cross, and the University of Hawaii Foundation. Under 501(c)(3) “exempt purposes” include:

“...charitable, religious, educational, scientific, literary, testing for public safety, fostering national or international amateur sports competition, and preventing cruelty to children or animals. The term *charitable* is used in its generally accepted legal sense and includes relief of the poor, the distressed, or the underprivileged; advancement of religion; advancement of education or science; erecting or maintaining public buildings, monuments, or works; lessening the burdens of government; lessening neighborhood tensions; eliminating prejudice and discrimination; defending human and civil rights secured by law; and combating community deterioration and juvenile delinquency.” [IRS Bulletin]

The stated purpose for MCH is to engage in what the Grand Lodge adopted as its official charity: “The Keiki I.D. Program”, known in other jurisdictions as “Masonic CHIP.” However, MCH may undertake other charitable activities, bearing in mind that we have to describe our actions each year, and they have to be “exclusively” for exempt purposes.

As many of you know, we once coined the name “Hawaii Masonic Charities” as the Grand Lodge’s charitable arm. “Masonic Charities of Hawaii” was adopted so as not to confuse references to “HMC”, the charity, with HMC, the Hawaii Masonic Code. Its voting members are all the living Past Grand Masters and all incumbent Senior Wardens of the constituent lodges, plus the incumbent Grand Treasurer and Grand Secretary. The non-voting members are all persons making donations to MCH during the current year.

The board consists of six directors. The initial directors are: Bruce Bonnell (President), Lee Skinner (Vice-President), Ernest Yamane, Randy T. S. Chang (Secretary), Bert Alarcon (Treasurer) and Don Wilson. Please understand that the initial directors and officers were named in MCH’s initial resolutions, for organizational purposes only. The voting members are free to increase the number of directors, name new directors (for staggered three-year terms), etc. at MCH’s next annual or special meeting.

I should also point out that the following persons may NOT serve as directors: the incumbent Grand Master, Deputy Grand Master, Senior Grand Warden, or Junior Grand Warden. This restriction was inserted to avoid the appearance of having identical governing bodies (“interlocking directorates”) for the Grand Lodge and MCH, a characteristic of private foundations, a classification which is less desirable than a public charity. All the above organizational information is contained in the Articles and Bylaws, copies of which are at the Grand Lodge office.

The “sorta bad news” is that the IRS has openly declared that it intends to hold 501(c)(3) organizations to strict compliance with applicable tax regulations. There has been much abuse in this area, particularly involving donations made for private or individual benefit – an absolute no-no for tax-exempt organizations.

Thus, we must file the organization’s tax returns in timely fashion. We must give written acknowledgement of all gifts of \$75 or more. We must be careful that our fund-raising activities do not constitute engaging in an “unrelated business” that may either subject us to tax, or the loss of our tax-exempt status altogether. We must make our financial records available to any member of the public, on request. We must always keep our organizational records (e.g., minutes, inventory, financial documents) in order. And above all, we must make sure that we engage only in activities that are for “exempt purposes”.

There is no question that MCH will make it much easier to solicit gifts and bequests in support of our charitable activities. We hope that MCH can expand such charitable purposes, and that someday it may even be able to rent or purchase its own office or building (and maybe rent a portion of it to the Grand Lodge). But now that we have this important vehicle, we must be ever vigilant in our compliance with all applicable laws.

Mark Lovell (Chaplain of Lodge Le Progres) graciously translated the document for all of us to understand.

The true Masonic creed consists of good morals. Therefore, do good work for the love and welfare of oneself.

Love the good in people, help the weak, and avoid the evil. Speak concisely with your superiors, cautiously with your equals, sincerely with your friends, with care to your subordinates, and compassionately with the poor.

Do not flatter your brothers; such is a moral trespass. If your brother flatters you, do not permit it to corrupt your good sense.

If destiny gives you a son, thank God. But, be mindful of the responsibility that is required of you, for this child is a reflection of His nature. Until 10 years of age, be his master. Until 20 years, his father. Until death, his friend.

Read, and enrich oneself. Watch and learn. Reflect and work. Being ever available for betterment of one's brothers is in turn an improvement upon oneself

Always abide by the voice of one's conscience. Be a father to the poor. Every unkind sentiment towards another will only revisit hardship upon oneself, in kind. Avoid conflict, and avoid antagonizing; always let reason guide you. Respect women. Do not ever abuse their weakness; rather die, than dishonor them
