

FORMAL GRAND LODGE OPENING

MEMBERSHIP COUNT

As always, first let's talk numbers for this last year,...

For the period covering January 1, 2023 through December 31, 2023, we started off the year with 11 chartered lodges and I am happy to report that at this time all lodges are

current in their per-capita payments and all are authorized to have representation at this year's Annual Communication.

Falling under the category of encouraging news,...

- Our gains for 2023 were 55 which included raisings, affiliations and restorations. This was down from our 108 gains from the previous year
- Our losses for 2023 were 104 which included deaths, suspensions and demits. This was increase from our 82 losses from last year.

So, when all was said and done, we had an overall decrease of 49 members for 2023 for a total 2023 ending membership count of 1567.

In gong back for a few years to see what the trend is and where we are leaking members at here are a few figures for you.

2023 34 Deaths 22 Demits 8 Expulsions	40 NPD's
2022 27 Deaths 14 Demits 0 Expulsions	41 NPD's
2021 13 Deaths 14 Demits 0 Expulsions	47 NPD's

While all in all, 2 of the major losses come from deaths and expulsions which are unavoidable. Our NPD's are slowing down albeit not fast enough, but it appears an alarming increase in demits has happened from over the previous 2 years.

How can we reverse this trend? Well, many man thousands of man-hours over the years have been spent across the jurisdictions to try to answer that common questions with nothing conclusive figured out. Maybe we need to make a concerted effort into exploring what we are doing in our individual lodges to see what might work for us here in Hawaii. And if we can't find out how to reverse it, at least find out what are the causes of NPD's/

A full membership report including individual lodge membership counts will be published along with the proceedings of this Annual Communication when they come out.

GROUPABLE ON-LINE MEMBERSHIP SYSTEM

AGAIN, Groupable:M2 continues to evolve adding more features to make our lives as secretaries even simpler and reporting more accurate. Their 3 products, Groupable M2: (the membership system), OLP (Our Lodge Page lodge web site) and Passport (the virtual dues card system all work together with each other and sync most of their information automatically.

We are in our 2nd year of our virtual dues card system and kudos to the team at Groupable, with little or no bugs. The only true bug reported was that there are a few having difficulty gaining access with the new Galaxy S23 phones. But that is being looked into as to why most work but only a few don't. Individual phone settings seem to be the culprit at this point.

On the bright side, the virtual dues cards now display a "Life Membership" status for those who have a life membership. This had been a common request the last 2 years and the Groupable Team just made it happen. It took a little while mainly because any changes made to Groupable, OLP of Passport have to be acceptable for all jurisdictions using the same product.

They have also implemented a new user interface to help simplify and streamline input making our job as secretaries simpler as well. But probably the biggest improvement this year, at least in my opinion, is their self-help option. Besides having a list of help videos that are all on YouTube as well as listed in Groupable, they have included icons in every window for help specific tasks. What a great time saver that is.

What is in store for the future for Groupable? Some of our secretaries have been experiencing a few issues when trying to communicate with the WePay people. Not just in our jurisdiction but also other jurisdictions as well. So, with that in mind, the gang at Groupable are almost done with negotiations with PayPal to convert over to them. The problem actually stems from JP Morgan Chase who is the parent corporation of WePay and is trying to phase out the whole WePay system.

Then the next thing on the horizon is an integration between the Groupable membership system and OLP (Our Lodge Page) web sites. They will merge together into 1 system instead of being 2 separate systems, making communication between the 2 simpler and only requiring 1 log in. They are both owned by Groupable anyways.

I would like to express our thanks to the whole Groupable Team for continually working with their jurisdictions to help make a better product. Especially that of Mark and Sylva Manard, the owners for allowing us personal and even after-hours access to them whenever something is needed.

MASONIC CHARITIES OF HAWAII ANNUAL REPORT

The Grand Master then called upon Worshipful David H. Gomes, chairman of the Masonic Charities Committee for their annual report.

Aloha Most Worshipful Verity, Grand Master of Masons in Hawaii,

I'm writing to you today with a look back at the Masonic Charities of Hawaii's (MCoH) activities in 2023. As you'll see in this report, our brothers have been busy making a positive impact across the islands and in the larger world around us.

MCoH continued its mission to support our local communities throughout the year. We examined and started a variety of projects, from neighborhood beautification through antigraffiti efforts to fostering future leaders through the Knights of Rizal program. These initiatives, along with our ongoing support for the Wounded Warriors Program, reflect our commitment to serving Hawaii.

Financially, 2023 presented both challenges and triumphs. While maintaining complete financial transparency at every meeting proved difficult, we received significant donations and actively fundraised to ensure our projects had the resources they needed. Our board meticulously reviewed investments and expenses to guarantee alignment with our mission and financial well-being.

One of our proudest moments in 2023 was our response to the Lahaina Wildfire. MCoH played a vital role in aiding victims. We launched fundraising campaigns, like a GoFundMe page, and collaborated with other organizations to maximize the impact of our assistance. This exemplified the MCoH spirit of community engagement and responsiveness in times of crisis. Our main bank account now holds over \$500,000, with many of those funds being given through the generosity of the Masonic Family for the victims of the Lahaina Wildfire. Your diligence in traveling to different jurisdictions to request their assistance in raising the funds necessary for those affected by the wildfire have been vital to our efforts to be able to consistently give relief to those in need of it most.

Internally, we also focused on strengthening our organization. Discussions on bylaws, mission/vision statements, and internal audits were ongoing throughout the year. The board deliberated on paraphernalia sales, investment opportunities, and potential improvements to our infrastructure, including website development and improved communication tools.

The annual report details the specific outcomes of projects like the Anti-Graffiti Project, which not only beautified neighborhoods but also helped deter vandalism. The Knights of Rizal program continued to engage young people in leadership and community service activities, despite some participation hurdles. We remain dedicated to finding solutions to these challenges and ensuring these vital programs thrive.

MCoH, like many organizations, grappled with operational hurdles in 2023. We're actively seeking solutions to improve our financial reporting, project management, and strategic planning. The board is committed to enhancing our organizational performance and maximizing our community impact.

Overall, the 2023 report reflects a year of unwavering dedication, responsible financial stewardship, and a deep commitment to serving the people of Hawaii. The achievements

Before I begin my message to you I would like to invite you all to join with us to celebrate Kauai Lodge's 100th anniversary on Oct 19th at the Hookllau Hotel dining Hall at 5:30 PM.

More detailed information will be forthcoming through the Grand Lodge channels. Please, bringing your family to Kauai for the weekend, enjoy our island and celebrate with us.

I also would be remiss if I did not mention that Pearl Harbor Lodge will be celebrating their 100th anniversary as well this year.

In My message this morning I would like to consider these historical milestones in the context of the flow of Masonic history over the past centuries.

Masonry has persisted through wars, where the Fraternity of Masons served as the only real family men had as they were deployed.

Masonry was present during births of nations and contributed greatly to the concepts of governance that we now enjoy.

Masonry has been around during peace and prosperity and has been a beacon of stability and an example of what it means to be a good man.

So in the context of this flow of history, where do we stand today?

I believe that we are in a period to quote from Bob Dylan "The Times they are a Changin" Come gather round people wherever you roam and admit the waters around have grown and except it that soon you'll be drenched to the bone If the time to you is worth savin, Then you better start swimming or you'll sink like a stone for times they are a changin.

We are currently in a Tsunami of CHANGE and people are frantically looking for something to hold on to.

In these days in which we live all traditions and standards are up for grabs. Throughout the ages all societies change. But what is different today is the speed of the transition facilitated by modern media.

There are many areas we could consider but for us here today I would like to consider what it's like to be a young man growing up in today's world.

A time when the term toxic masculinity has been thrown around.

Male heroes in the media are few and far between these days.

And the numbers of young men in our universities has dropped sharply.

I've put 4 kids into UH over the past years. I have noticed more and more as I walk on the UH campus.

Where are the young men?

University of Hawaii at Manoa has a total undergraduate enrollment of 14,198 (fall 2022), with a gender distribution of 40% male students and 60% female students.

My experience with *Medical Students*, 2 out of 12 were males

WE live in a world today where role models for young men are few and far between. Especially in broken homes.

This brings us back to Freemasonry.

WE my brothers are the guardians of a time capsule. In that time capsule are foundation stones and time-tested guide stones that are fabric of society. It's why we work hard to keep Freemasonry alive and our Lodges alive. Because we have been entrusted with a very precious thing.

WHAT DOES IT MEAN TO BE A GOOD MAN?

There is a generation of men out there looking for a life line and we need to be ready to throw it out there. TODAY The time is today. WE need to think about some things.

I would like to bring this out of theoretical oratory to sharing A bit of my personal love and experience with Freemasonry. I fully understand that many men come to Freemasonry for different reasons.

This is my story. I am taking the time to share it for a reason.

I was born in 1953 and was growing up as a young man in the late 60s and early seventies a time much like this with cultural and societal change and turmoil.

Growing up in Southern Calif in a divorced household, without a strong Father figure in the house: like many I gravitated to other role models Trying to figure out what kind of man I would become. I was heavily influenced by what could be called the counter coulter. The fact that I just quoted Bob Dylan might have been a clue.

It was the culture of, "1.2.3 what are we fighting for? Don't ask me, I don't give a damn. Next stop is Vietnam

That was Country Joe and the Fish not Bob Dylan

I later found faith in the Jesus people movement just before getting my draft number picked at #33.

I will fast forward through a teenage marriage of 17 years with 2 kids who are both now fine adults.

My experience as an army medic and medical training at Emery Medical School as a PA on the GI Bill.

I joined a Christian mission's group and served as a medical missionary in SE Asia and central America during the 80s. I organized medical teams and helped bring equipment for a whole surgical suite to the Belmopan Hospital in Belize.

In the late 80s I was awarded the Humanitarian of the Year award by the American Academy of Physician Assistants at their convention in LA. My divorced mother and father were sitting together in the audience and they were proud. It was at this time my marriage was coming apart as well as my religion.

I did not have a loss of faith but a crisis of my religion not being big enough.

I entered a time of great turmoil in my life but ended up meeting my wife Mary Ann and moving to Kauai to find wonderful happiness.

It was on Kauai that I discovered the Masons and a place where my faith was not bound to dogmas that I found intellectually unacceptable. I truly found a home in Masonry where I was still challenged to be a good man but my personal quest for faith was respected by my brothers as I respected theirs.

This is my very personal love for Freemasonry

And this is why I feel strongly that the time is now for the Fraternity to step up.

I would like to point out that during all this time while I was going through life I never once heard about the Freemasons. I often wonder what turns my life would have taken had I found the Masons earlier.

I believe Freemasonry missed the boat when comes to my boomer generation. This is born out by cold facts.

In these changing times, We don't want to sink like a stone, but we want to be the one with a lifeline to other men.

In my medical Training I went to a very good medical school, Emery university. It was world renown in the area of Cardiology.

There was a physician on the staff that had written a book about patients who had died on the table and were brought back to life. I actually had a chance to speak to some of these patients that had such experiences, and they all seem to come back with a sense of what's really important in life and forget the small stuff.

Kauai Lodge also has had many such experiences and we keep coming back .

But I tend to focus on what is important and forget the small stuff.

Fortunately we don't need to spend time figuring out what is really important in Masonry. Our ritual has clearly spelled it out for when it says... BTW inspectors, I'm over 70 and not trying to get every word right.

Be especially careful to maintain in its fullest splendor !

PROPOSED RESOLUTIONS 2024 ANNUAL COMMUNICATION

GRAND LODGE OF HAWAII PROPOSED RESOLUTION NO. 2024–01 New Secretary's Proficiency

Proficiency requirements exist in our Masonic code for many different officers but they are primarilly for positions in regards to ritual and not administrative. Over the years it has proven that a serious exists when a lodge transitions in a new secretary with little or no training and is not prepared for the requirements of that postion.

A lodge's ability to function properly can be severely hampered by a lodge secretary who does not understand the requirements and procedures that this position demands. A poorly prepared secretary cand hinder a lodge so much that it takes years to get the lodge back on track as there are occasions when problems are not discovered until it is too late to rectify easily.

If there are proficiency requirements for certain officer positions to advance to a postion which is only be expected to be held for 1 year, why isn't there a proficiency requirement for a secretary who is hoped to hold that position for years to come.

As this is a chronic situation year after year, this proponent asks a favorable vote that this legislation be approved as emergent and proposes the follow addition to the Hawaii Masonic Code to put step guards in place sooner rather than later.

NOW, THEREFORE, BE IT RESOLVED that a new section §2521 be added to the Hawaii Masonic Code as follows:

§2521. QUALIFICATIONS OF SECRETARY. Before a brother who has never held the position of Lodge Secretary in this jurisdiction before or one has not held the position for more than 5 years, he must first pass a satisfactory proficiency as prescribed by the Grand Secretary before he can be installed as such. This proficiency is to include but not necessarily be limited to a familiarity with 1) Usage of current membership system; 2) knowledge of procedures such as acceptance of membership applications, annual reporting responsibilities, and communication protocols with other lodges within our jurisdiction and without, and 3) a general familiarity of the Hawaii Masonic Code and how to search its contents.

GRAND LODGE OF HAWAII PROPOSED RESOLUTION NO. 2024–02 To Allow Electronic Archival of Lodge Records

BACKGROUND: The Hawaii Masonic Code (§2086n) allows that "microfilming of Lodge records is permissible" under the conditions that only a Mason may read the records during the archival process, and that the singular archival copy may be made for the Lodge.

Microfilming was a popular method for records retention in the later decades of the last century. Unfortunately, microfilms are subject to the same deterioration that impact paper records - heat, humidity, and mishandling lead to the degradation of microfilms. As archival technologies progressed, access to the specialized cameras (to capture the document), film processing (to develop the microfilm), and readers (to review the archives) have become increasingly scarce.

INTENT: With the near-universal adoption of modern electronic document management systems, the practice of microfilming paper records is obsolete. This resolution proposes to modernize Article 2086n to allow digital scanning and archiving technologies instead of using microfilm/microfiche to preserve our most critical Lodge records.

HMC §2548 describes the First Duty of the Secretary to present approved or corrected minutes "...to the Master *for his signature*" (emphasis added). While it is a common practice for minutes (and other documents) to be prepared electronically, they are not lodge records until signed by the Master.

This proposed revision to HMC §2086n is not directive; it offers an updated option to the Lodge to preserve its records. The proponent encourages constituent Lodges to assess the current physical condition of their records and to consider digital preservation.

REFERENCES: <u>HMC §2086</u> standardizes the By-Laws of every Lodge of this Jurisdiction. <u>Article XI, Section 1</u> of the By-Laws codifies that any proceeding of the Lodge, not proper to be made public, shall not be disclosed outside of the Lodge. <u>HMC §2086n</u> is an annotation to Article XI, which allows for microfilming. <u>HMC §2548b</u> assigns the duty of keeping and maintaining records to the Secretary.

NOW, THEREFORE, BE IT RESOLVED that section §2086n of the Hawaii Masonic Code be amended as follows:

"§2086n. Annotation to Article XI, Section 1, Uniform Code of By-Laws. Microfilming Digital archiving of Lodge records is permissible under the following conditions: If circumstances do not exist where only a Mason may read the records during the microfilming process, then, a legally binding contract shall be entered into with a reputable company, individual or organization that specifies only one (1) each microfilm copy shall be made of each document or page of lodge records. This copy shall be for the lodge; and that no other microfilm copies shall be made at the time, under any circumstances for either company records/samples or for sale or donation to any individual or organization. <u>by</u>, or <u>under the direction of</u>, the Lodge Secretary. Access to these archives shall be at the discretion and <u>direction of the Master and coordinated by the Secretary.</u>

The Grand Lodge will provide an appropriate contract upon receipt of a written request from the Master of the Lodge.

The microfilming digital archiving of trial records is not permitted."

GRAND LODGE OF HAWAII PROPOSED RESOLUTION NO. 2024–03 NPD Restoration With Demit

To amend Section 2820 of the Hawaii Masonic Code by clarifying certain sections and allowing members suspended for non-payment of dues to be restored for purposes of demitting.

A brother suspended by his lodge for more than two years for non-payment of dues may wish to settle his debt to the lodge and then demit from that lodge. Under present rules, his application for restoration must be made at a stated meeting, lay over till the next stated meeting (presumably to allow for investigation), and be approved by two-thirds of those attending the second stated meeting in a secret ballot. Unfortunately, the suspended brother might encounter difficulty getting his application approved. He might not be known to the current lodge members, or the composition of the lodge might now be very different from when the brother was active.

If the brother pays the arrears owed for members suspended "NPD" and simply wishes to demit from the lodge, it makes little sense to place obstacles before him in order to prevent his moving on. Both sides should be satisfied – the Lodge will obtain what is owed, and the brother will settle his accounts and be able to move on. This proposed amendment was part of an edict issued by the Grand Master during his 2023-24 term.

IT IS THEREFORE PROPOSED to amend HMC Section 2820 as follows [deleted material is crossed out, new material is underscored]:

§2820. RESTORATION AFTER TWO YEARS. Should If any member has been suspended by his Lodge for non-payment of dues or have the same remitted by his Lodge for more than two years for non-payment of dues, said member may apply to his Lodge for restoration; however such member shall not be restored except by a two-thirds vote by secret ballot of all members present at the next stated meeting after the application for restoration is presented. He shall thereafter pay, as a condition of his restoration, the arrearage dues in arrears for the two years before his suspension plus the current year (two plus one) unless such arrearage and dues have been remitted by his Lodge.

§2820a. No formal application for restoration is required, and the Lodge should use any means of investigation to ascertain whether the applicant is worthy. The Master and the Lodge, however, shall satisfy themselves fully before proceeding to a vote on the application for restoration. A committee may be appointed as in the case of other applications or any other steps may be taken to ascertain the conduct of the member during the time of his suspension.

§2820b. A petition denied may be renewed at a subsequent stated meeting. §2820c. A member suspended for more than two years for non-payment of dues may also apply to his Lodge for restoration for the sole purpose of demitting from such Lodge immediately after restoration. If such member's application for restoration contains a request to demit and is accompanied by payment of the dues in arrears for the two years preceding his suspension plus dues for the year of restoration, his membership shall be restored forthwith without any waiting period, investigation or balloting. Immediately after restoration and the validation of said payment, the Lodge shall grant him an open demit.

GRAND LODGE OF HAWAII PROPOSED RESOLUTION NO. 2024–04 Increase Dipensation Fees

To amend Article IV, Section 1702, of the Hawaii Masonic Code by updating the amount of fees charged for Dispensations.

Article IV, Section 1702 of the Code provides for specific fees to be charged by the Grand Lodge for Dispensations to form a new Lodge, to ballot on an applicant without investigation, and so on. This fee schedule has not been changed for many years, and is therefore obsolete and unnecessarily detailed. It also does not provide for every instance when a Dispensation is required or desired.

It is therefore proposed that Article IV, Section 1702, be amended as follows [deleted material is crossed out, new material is underscored]:

§1702. FEES. The following fees shall be charged by the Grand Lodge:

1st. For a Dispensation to form a new Lodge, the sum of seventy-five dollars.

2nd. For a charter to perpetuate a Lodge, the sum of fifty dollars.

3rd. For each Dispensation to ballot for an applicant for the degrees, without the reference to a committee, the sum of ten dollars.

4th. For each Dispensation to receive and act upon the application of a rejected candidate for the degrees, within a period less than twelve months, the sum of ten dollars.

1st. For any Dispensation, the sum of one hundred dollars; provided, that the Grand Master may for good reason waive or lower the fee.

5th. <u>2nd</u>. For a diploma of any kind, a sum to be fixed from time to time by the Grand Secretary, except when issued for the widow or minor children of a deceased Mason, in which case there shall be no charge, but no diploma shall issue except upon the presentation to the Grand Secretary of a certificate from the Secretary of a Lodge, on one of the forms prescribed therefore.

6th. <u>**3**rd</u>. For the Annual Proceedings, other publications, blanks and supplies required by Grand Lodge to be produced and sold, such sum or sums as fixed from time to time by the Grand Secretary.

In no case shall any of the documents <u>or supplies</u> referred to herein be issued until the fees therefore shall have been paid to the Grand Secretary<u>, unless the Grand</u> <u>Secretary has arranged beforehand to issue the documents or supplies and then</u> <u>send an invoice to the recipient of such documents and/or supplies</u>.

GRAND LODGE OF HAWAII PROPOSED RESOLUTION NO. 2024–05 Terminology Change Between "Suspended" and "Dropped" Members

Our Hawaii Masonic Code outlines the notification procedure that lodge in this jurisdiction must follow in order to suspend a member for non-payment of dues. When the suspension process has been completed, the HMC directs that *"member shall immediately, and of itself, suspend his membership in all Lodges in this jurisdiction"* without any further action by the other lodges.

This means that the other lodges he was a member of has had his membership automatically terminated without that lodge going through an actual suspension process themselves. Therein lies the confusion. Using the term "suspended" in the lodges a member was terminated from may be misinterpreted especially when it comes to the case of the reinstatement process by those lodges in which he was automatically terminated from.

IN order to clarify the distinction between being officially suspended by one lodge and being automatically terminated in another lodge, this proponent suggests to change the words "suspend or suspended" to "drop or dropped" in certain areas of the HMC to avoid confusion and misinterpretation.

NOW, THEREFORE, BE IT RESOLVED that a new section §2402(6) of the Hawaii Masonic Code be amended as follows:

§2402. MULTIPLE MEMBERSHIP. This Grand Lodge recognizes and authorizes membership in more than one Lodge under the following conditions...

6. Suspension by a Lodge in the jurisdiction of this Grand Lodge for non-payment of dues of a multiple member shall immediately, and of itself, suspend drop his membership in all other Lodges in this jurisdiction, and the Secretary of any Lodge suspending such a member shall immediately notify the Grand Secretary and also every other Lodge in which the multiple member holds membership. Like notice shall be given in case of reinstatement by a Lodge in the jurisdiction of the Grand Lodge of Hawaii which shall immediately and automatically restore him to membership in every other Lodge in this jurisdiction of which he was dropped as a member upon payment of any dues required or the performance of any other obligation required for such restoration to membership.

When non-payment of dues is the cause of suspension, such action shall become effective only after a sixty-day prior Notice of Intent to Suspend has been sent to every other Lodge in which the member holds membership, during which period such other Lodge may contact the member in an effort to avoid such suspension. If within said sixty-day period such member has failed to obtain good standing in all Lodges involved, he shall be suspended, and such suspension shall immediately terminate drop his membership in all Lodges in this jurisdiction.

Suspension by a Lodge in any other Grand Jurisdiction for non-payment of dues shall forthwith suspend drop his membership in all Lodges in this jurisdiction but shall be handled in the same manner as provided in this section for members suspended by a Lodge in this jurisdiction by giving sixty days notice, and provided further, that the restoration of such a member shall be in the same manner as provided in <u>section §2820 of</u> this Code.

GRAND LODGE OF HAWAII, F&AM PROPOSED RESOLUTION NO. 2024 –06

To amend Sections 2516, 2518 and 2520 of the Hawaii Masonic Code to make clear that the Wardens must know the work of the Senior Deacon in order to qualify for office, and to specify the Senior Deacon's work in the second section of the Third Degree.

Some have suggested that one may become a Junior Warden without knowing the Senior Deacon's work or lectures, as long as he can confer the First Degree and give the First Degree Lectures, because the HMC does not expressly say that. In other words, one could become a Junior or Senior Warden without ever knowing the Middle Chamber Lecture or other work of the Senior Deacon

Since §2514 requires the Master-elect to know the work and lecture of "all three degrees", the clear implication is that the Wardens must also be so qualified. Indeed, the "established practice" in this and other jurisdictions with a progressive line is that the Junior (and Senior) Warden must know the work of the Senior Deacon, even if he has never been installed in that office. This requirement is also contained in the charge to the Wardens in the installation ceremony.

Under this proposed amendment knowing the work of the Senior Deacon will no longer be merely implied, but will be expressly required in order to qualify as a Warden. (Note: the requirement is that the Warden must "know" the work, but he need not actually serve as Senior Warden.)

The proposed amendment will also specify that the Senior Deacon's "work" will include his performance in the second section of the Third Degree only up to the point where the Senior Deacon turns into the Third Fellowcraft. (Although the cipher refers to the actor as "SD" after that point, such reference is continued in order to avoid confusing the reader by suggesting that they are two different officers.)

THEREFORE, IT IS PROPOSED THAT THE FOLLOWING AMENDMENTS BE MADE TO SECTIONS OF THE CODE PERTAINING TO QUALIFICATION FOR OFFICE (deleted material is crossed out, added material is underscored):

§2516. QUALIFICATIONS OF SENIOR WARDEN. Before a Senior Warden-elect can be installed there shall be presented to the installing officer the certificate of either the Grand Lecturer, the Assistant Grand Lecturer of the District in which his Lodge is situated, or the Inspector of the District in which his Lodge is situated, certifying that he has personally examined such Senior Warden-elect, and that he is qualified to give the work and lectures of the First and Second Degrees and of the Senior Deacon and; if he is to be installed on or after May 20,1989, that he has received a certificate of proficiency in the Candidate's Lecture of the Degree of Master Mason, and is thoroughly proficient in those portions of the Constitution and Regulations of the Grand Lodge which relate to the government of a Lodge.

§2518. QUALIFICATIONS OF JUNIOR WARDEN. Before a Junior Warden-elect can be installed there shall be presented to the installing officer the certificate of either the Grand Lecturer, the Assistant Grand Lecturer of the District in which his Lodge is situated, or the Inspector of the District in which his Lodge is situated, certifying that he has personally examined such Junior Warden-elect, and that he is qualified to give the work and lecture of the First Degree and of the Senior Deacon; if he is to be installed on or after May 20, 1989, that he has received a certificate of proficiency in the Candidate's Lecture of the Degree of Master Mason,

and is thoroughly proficient in those portions of the Constitution and Regulations of the Grand Lodge which relate to the government of a Lodge.

§2520. QUALIFICATIONS OF SENIOR DEACON. Before a <u>an appointed</u> Senior Deacon appointed can be installed there shall be presented to the installing officer the certificate of either the Grand Lecturer, the Assistant Grand Lecturer of the District in which his Lodge is situated, or the Inspector of the District in which his Lodge is situated, certifying that he has personally examined such Senior Deacon Appointed appointee; and that he is duly qualified to give his work, and in particular the lecture of the Second degree and the Senior Deacon's introduction, perambulation and "travel" with the candidate up to the point in the second section of the Third Degree when he becomes a Fellowcraft.

GRAND LODGE OF HAWAII PROPOSED RESOLUTION NO. 2024–07 Assaistant Grand Lecturer and Inspector Titles

Section 8 of the Hawaii Masonic Code outlines Grand Lodge Officer titles. As part of this section, Assistant Grand Lecturers are to be addressed as, "Worshipful."

Additionally, Section 1120, Inspectors, is silent as to the official title of Inspectors and they are recognized by their Past Master title of, "Worshipful."

However, it is common practice in other North American Grand Lodge Jurisdictions to recognize Assistant Grand Lecturers and Grand Lodge Inspectors as Very Worshipful in recognition of their commitment and dedication to the Grand Lodge. The title is also consistent with the level of authority in this Jurisdiction, that of being the Grand Master's representative.

NOW, THEREFORE, BE IT RESOLVED that sections §8 and §1120 of the Hawaii Masonic Code be amended as follows:

§8. MEMBERS AND ADDRESS. The Grand Lodge shall be composed of a Grand Master (whose address shall be Most Worshipful), a Deputy Grand Master, a Senior Grand Warden, and a Junior Grand Warden (whose addresses shall severally be Right Worshipful), a Grand Treasurer, and a Grand Secretary (whose addresses shall severally be Very Worshipful, or if not a P.M., Honorable), a Grand Lecturer (whose address shall be Very Worshipful), a Grand Chaplain (whose address shall be Very Reverend), the Assistant Grand Lecturers, (whose addresses shall severally be Very Worshipful), a Grand Orator, an Assistant Grand Treasurer, an Assistant Grand Secretary, a Grand Marshal, a Grand Standard Bearer, a Grand Sword Bearer, a Grand Bible Bearer, a Senior Grand Deacon, a Junior Grand Deacon, a Senior Grand Steward, a Junior Grand Steward, a Grand Historian, a Grand Director of Special Activities, a Grand Organist, a Grand Pursuivant, and a Grand Tiler (whose addresses shall severally be Worshipful, or if not a P.M., Honorable); together with all Past Grand Officers and Past Masters of this jurisdiction, and the Master and Wardens of the several chartered and duly constituted Lodges or the representatives thereof duly elected. A Past Grand Officer is one of the seven elective Grand Officers who has been regularly elected and installed and has served his term as such in this Grand Lodge.

§1120. INSPECTORS. The Grand Master shall divide the jurisdiction into districts, and shall appoint for each district an Inspector <u>whose address shall be Very Worshipful</u>, who shall be a Past Master of this jurisdiction, and who shall, before entering upon his duties, produce a certificate from the Grand Lecturer or an Assistant Grand Lecturer that he is proficient in the work and lectures adopted by the Grand Lodge and is qualified to act as Inspector. Each Inspector shall serve for a term of one year commencing in May, following the Grand Masters installation and terminating when his successor is installed.
